1. VISA APPLICATION FORM

- 2. COPY OF CNIC / FORM "B"
- 3. FOUR PHOTOGRAPHS WITHOUT BORDER (WHITE BACKGROUND 35 MM X 48 MM)
- 4. COVERING LETTER
- 5. PROOF / NATURE OF WORK IN PAKISTANI I.E.
  - A. SALARY EVIDENCE IF DEPENDENT.
  - B. PROPRIETORSHIP DEED OR PARTNERSHIP DEED IF OWNER OR PARTNER OF A COMPANY.
  - C. IN THE CASE OF THE OWNER/PARTNER OF THE COMPANY THE APPLICANT HAS TO SHOW A (PROPRIETOR OR PARTNERSHIP DEED DOCUMENTS).
  - D. INSCRIPTION TO THE CHAMBER OF COMMERCE AND INDUSTRY OR ANY OTHER GOVERNMENT ASSOCIATION.
- 6. COMPANY PROFILE DULLY FILLED IN EACH PART; SIGNED AND STAMPED BY THE OWNER/PROPRIETOR OF THE COMPANY.
- 7. INSCRIPTION TO THE CHAMBER OF COMMERCE AND INDUSTRY OR ANY OTHER GOVERNMENTAL ASSOCIATION.

## 8. CERTIFICATE TO:

COMPANY'S REGISTRATION WITH THE REGISTRAR OF COMPANIES EXPORT / IMPORT REGISTRATION WITH THE EXPORT PROMOTION BUREAU

- 9. LETTER OF CREDIT, BILL OF LADING, OR ANY OTHER EVIDENCE OF IMPORT OR EXPORT TOWARDS MALTA OR THE EUROPEAN COUNTRIES.
- 10. (A) AN INVITATION / GUARANTEE LETTER FROM THE MALTA COMPANY ALSO SEND DIRECTLY TO THE MALTA CONSULATE GENERAL KARACHI THROUGH FAX EXPLAINING IN DETAIL THE REASONS FOR THE BUSINESS TRIP TO MALTA AND ASSURING THAT THE APPLICANT WILL BE BACK TO PAKISTAN.
- 11. (B) CERTIFICATE OF INSCRIPTION OF THE MALTA COMPANY TO THE COMPETENT. "CAMERA DI COMMERCIO ALSO SENDS THROUGH FAX TO THIS CONSULATE GENERAL.
- 12. PERSONAL INCOME TAX DOCUMENTATION AND, IN THE CASE OF THE OWNER OR MEMBER OF THE PAKISTANI COMPANY THEN COMPANY INCOME TAX DOCUMENTATION IS REQUIRED.
- 13. PERSONAL/COMPANY'S BANK STATEMENT OF THE LAST SIX MONTHS + BANK CERTIFICATE (ACCOUNT MAINTENANCE CERTIFICATE).
- 14. SUFFICIENT FINANCIAL FUNDS FOR THE DURATION OF THE VISIT ABROAD (TRAVELER CHEQUES, CREDIT CARDS, OR BANK ALLOWANCE STAMPED ON THE PASSPORT) MUST BE PROVIDED TO THE OFFICE OTHERWISE THE FRONTIER AUTHORITIES IN ITALY MAY REFUSE TO GIVE THE ENTRY IF THE ABOVE-MENTIONED FINANCIAL REQUIREMENTS ARE NOT SUPPLIED.
- 15. TRAVELER'S ACCIDENT & HOSPITALIZATION (SICKNESS) POLICY.
- 16. MARRIAGE REGISTRATION CERTIFICATE (MRC).
- 17. FAMILY REGISTRATION CERTIFICATE (FRC) ISSUED BY NADRA.
- 18. COPY OF POLIO VACCINATION CERTIFICATE
- 19. AIRLINE TICKET WITH A CONFIRMED RETURN DATE.
- 20. HOTEL RESERVATION CONFIRMED.
